Hard Words:

Unregistrable Movable Dwelling: a movable dwelling that— (a) is constructed on a chassis or in prefabricated sections; and
(b) once installed, is a freestanding dwelling with solid walls and roof; and
(c) is not a registrable movable dwelling.

Dwelling: A house, flat, or other place of residence

Rigid Annex: An extra part, unable to bend or be forced out of shape

Manufacturers: A person or company that makes goods for sale

Compliance: The action or fact of meeting with a wish or command

Regulations: Rules that have to be followed

Requirements: A thing that is needed or wanted.
